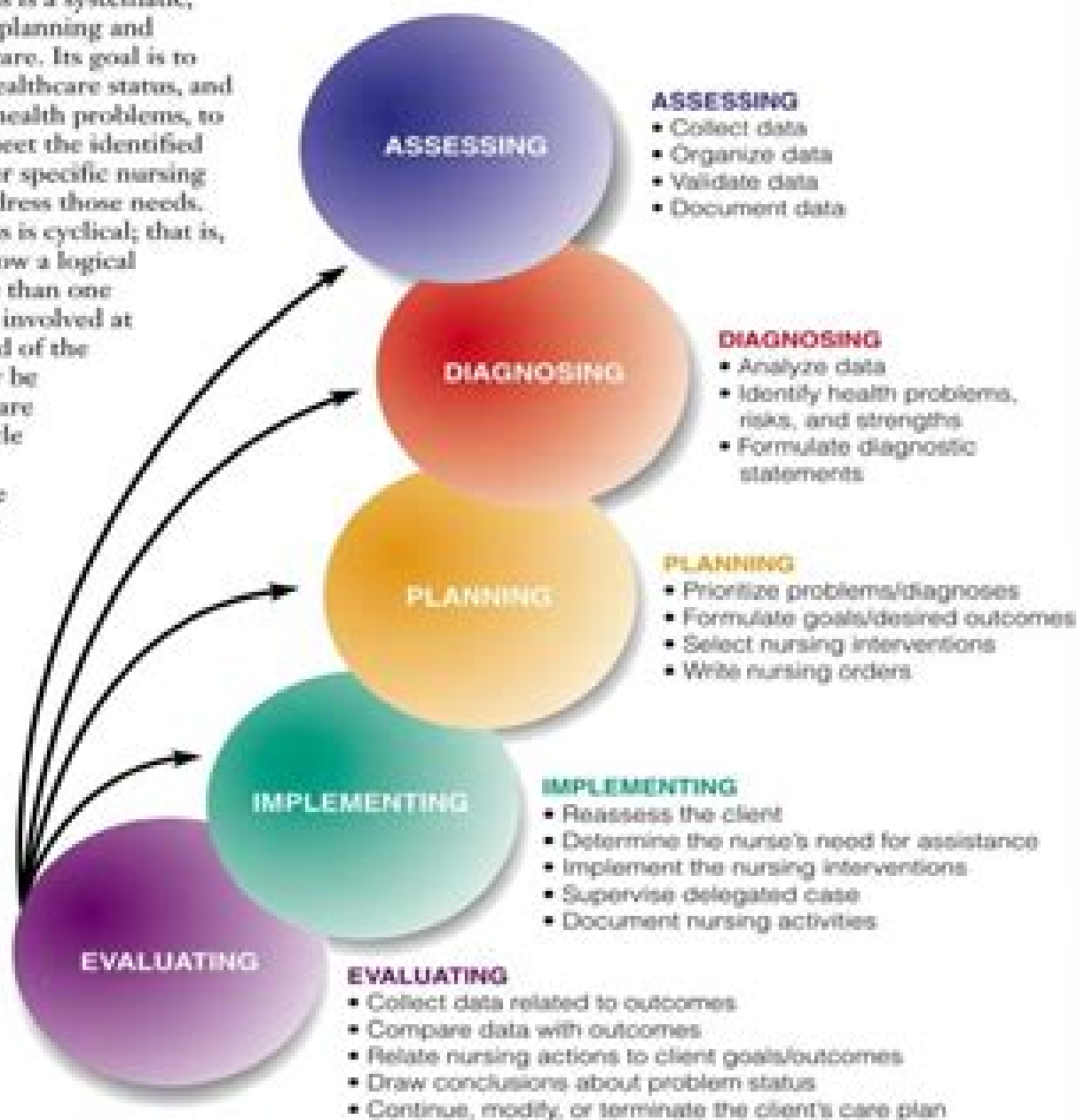


THE NURSING PROCESS IN ACTION

The nursing process is a systematic, rational method of planning and providing nursing care. Its goal is to identify a client's healthcare status, and actual or potential health problems, to establish plans to meet the identified needs, and to deliver specific nursing interventions to address those needs. The nursing process is cyclical; that is, its components follow a logical sequence, but more than one component may be involved at one time. At the end of the first cycle, care may be terminated if goals are achieved, or the cycle may continue with reassessment, or the plan of care may be modified.
