Low-Probability High-Consequence Risk Analysis Ray Waller, 2013-11-21 In recent years public attention has focused on an array of low probability high consequence LC HC events that pose a significant threat to human health safety and the environment At the same time public and private sector responsibilities for the assessment and management of such events have grown because of a perceived need to anticipate prevent or reduce the risks In attempting to meet these responsibilities legislative judicial regulatory and private sector institutions have had to deal with the extraordinarily complex problem of assessing and balancing LP HC risks against the costs and benefits of risk reduction The need to help society cope with LP HC events such as nuclear power plant accidents toxic spills chemical plant explosions and transportation accidents has given rise to the development of a new intellectual endeavor LP HC risk analysis The scope and complexity of these analyses require a high degree of cooperative effort on the part of specialists from many fields Analyzing technical social and value issues requires the efforts of physicists biologists geneticists statisticians chemists engineers political scientists sociologists decision analysts management scientists economists psychologists ethicists lawyers and policy analysts Included in this volume are papers by authors in each of these disciplines The papers share in common a focus on one or more of the following questions that are generic to the analysis of LP HC risks

Uncertainty in Risk Assessment, Risk Management, and Decision Making

The subject of this volume, uncertainties in risk assessment and management, reflects an important theme in health safety and environmental decision making. Most technological hazards are characterized by substantial uncertainty. Recent examples include nuclear waste disposal, acid rain, asbestos in schools, carcinogens in food, and hazardous waste dealing with such uncertainty is arguably the most difficult and challenging task facing risk assessors and managers today. Four primary sources of uncertainty in risk assessment and management can be identified: 1) uncertainties about definitions; 2) uncertainties about scientific facts; 3) uncertainties about risk perceptions and attitudes; and 4) uncertainties about values. Uncertainties about definitions derive primarily from disagreements about the meaning and interpretation of key concepts such as probability. Uncertainties about scientific facts derive primarily from disagreements about failure modes, the probability and magnitude of adverse health or environmental consequences, cause and effect relationships, dose response relationships, and exposure patterns. Uncertainties about risk perceptions and attitudes derive primarily from disagreements about what constitutes a significant or acceptable level of risk. Uncertainties about values derive primarily from disagreements about the desirability or worth of alternative risk management actions or consequences. The papers in this volume address each of these sources of uncertainty from a variety of perspectives. Reflecting the broad scope of risk assessment and risk management research, the papers include contributions from safety engineers, epidemiologists, toxicologists, chemists, biostatisticians, biologists, decision analysts, economists, psychologists, political scientists, sociologists, ethicists, and lawyers.

The theme of this volume, risk analysis in the private sector, reflects a changing emphasis in risk analysis. Until recently, attention has been focused on risk analyses conducted in support of federal regulatory decision making. Such analyses have been used to help set safety standards, to illuminate issues of regulatory concern, and to evaluate regulatory alternatives. As this volume indicates, however, risk analysis encompasses a broader set of activities. Analyses performed by

private sector institutions aimed at preventing or reducing potential adverse health or environmental effects also play an important part in societal risk management. In virtually all societies there have been strong incentives for the private sector to conduct such analyses. These incentives range from moral or altruistic norms and values to simple self interest based on fear of monetary loss, possible civil or criminal litigation or punitive or restrictive government action. The petroleum industry is enduring difficult financial times because of the continuing depressed price of crude oil on the world market. This has caused major corporate restructuring and reductions in staff throughout the industry. Because oil exploration must now be done with fewer people under more difficult economic constraints, it is essential that the most effective and efficient procedures be used. *Computing Risk for Oil Prospects* describes how prospect risk assessment, predicting the distribution of financial gains or losses that may result from the drilling of an exploration well, can be done using objective procedures implemented on personal computers. The procedures include analyses of historical data, interpretation of geological and geophysical data and financial calculations to yield a spectrum of the possible consequences of decisions. Full information on loading is given in Appendix A. Software Installation. Risk 1 diskette contains data files and executables and Risk 2 diskette contains only executables. The authors contend that the explorationist who develops a prospect should be involved in every facet of its analysis, including risk and financial assessments. This book provides the tools necessary for these tasks.

Risk Assessment in Setting National Priorities James J. Bonin, Donald E. Stevenson, 2013-03-08. The growing perception of the public and politicians that life is extremely risky has led to a dramatic and increasing interest in risk analysis. The risks may be very diverse as demonstrated by the range of subjects covered at the annual meetings of the Society for Risk Analysis. There is a need to pause and see how well the present approaches are serving the nation. The theme *Setting National Priorities*, which was chosen for the 1987 SRA Annual Meeting, reflects the concern that in dealing with individual kinds of risks, society may be more concerned with the trees than the forest. health or other risks Individual agencies have the responsibility for specific patterns of exposure but these are not integrated and balanced to determine how the nation as a whole can obtain the greatest benefit for the very large investment which is made in risk related research and analysis
