# Public law- Human Rights Act

- In the Reith Lectures 2019, Lord Sumption argues that the domain of law is encroaching excessively into the domain of politics; that the political process is shrinking while the legal process is expanding, dealing with issues that would previously have been dealt with in other ways – customs, conventions & political actors.
- In his view, this expansion is happening under the auspices of the rule of law and human rights, both of which have allowed judges to be creative and expansive in their role. He questions the competence, suitability and legitimacy of judges exercising that amount of power on issues which should "ideally" be for elected leaders.
- Lord Sumption notes that "democracies cannot operate on the basis that a bare majority takes one hundred percent of the political spoils" because it creates "larger and permanently disaffected groups".
- A state that is based on a winner-takes-all system "would quickly cease to be a political community"
- This is why modern constitutions "treat the people as the source of legitimacy, while placing barriers between them and the levers of power".
- The purpose is "to contain the fissiparous tendencies of democracy and to counter its inherent tendency to destroy itself when majorities become a source of instability and oppression" (Recall Plato's aversion to direct democracy?)
- This explains why most democracies have developed ways to "limit or dilute the power of majorities" Two of these ways that he identifies are:
- Representative Politics (the political process) and
- Law (the legal process)
- He is, however, quite critical of the expansion of the legal process, arguing that it is encroaching too much into the political process and in the process undermining democracy it is supposed to safeguard. This is most visible in the area of human rights and the rule of law.
- Law focuses on rights and is administered by professional judges. However judges, unlike political representatives are not accountable to the electorate
