Regulating International Business Sol Picciotto, Ruth Mayne, 2016-07-27 This timely book points the way towards a new positive regulatory framework for international investment following the failure of the Multilateral Agreement on Investment MAI It examines the flaws in free market strategies underpinning the recent phase of globalization in particular drawing out the lessons from the MAI which was suspended in October 1998 The authors explore an alternative based on a positive regulatory framework for international business aimed at maximizing the positive contribution to development of foreign investment and minimizing its negative social and environmental impacts The contributors include academics researchers for non governmental organizations and business and trade union representatives writing from a combination of economic legal and political perspectives The book combines academic analysis with grass roots and practical experience and suggests concrete policy proposals

Regulating Multinationals in Developing Countries Edwin Mujih, 2016-04-08 Edwin Mujih explores the difficulties associated with regulating multinational companies operating in developing countries with a particular focus on extractive industries The author highlights the need to establish an international legally binding framework to ensure that multinationals operate in a socially responsible manner to protect local communities and the environment Edwin Mujih's analysis reveals that the existing mechanisms for controlling the behaviour of huge multinational entities are of normative force only that these are particularly inadequate and that the notion of corporate social responsibility is only meaningful where behaviour can be legally regulated *Regulating Multinationals in Developing Countries* features a study of the Chad and Cameroon Oil and pipeline project which highlights the problems arising in countries that have neither the capacity nor the will to effectively regulate those operating within their borders The author has evaluated compliance by the parties with their social and environmental obligations He has found that despite controversy surrounding inadequate regulation of this project in its incipient stages the system that was put in place following huge opposition from the affected communities and from NGOs is worthy of attention and could stand as a model for similar projects elsewhere This first title in Gower's Corporate Social Responsibility Series to approach CSR from a legal perspective provides insight not just into the complexity surrounding efforts to regulate multinationals operating in countries with weak regulatory regimes but also into the fundamental nature of multinational corporations and the debate about different notions of CSR itself

The Multinational Firm Glenn Morgan, Peer Hull Kristensen, Richard Whitley, 2003

In contrast to the traditional view of multinational firms as cohesive rational actors maximizing the use of resources across national boundaries the contributors to this volume argue that they are complex social arenas where competing groups draw on resources from their own socially embedded locations in developing new transnational social relationships As firms seek to manage across national and institutional boundaries they stretch their existing capacities and routines and develop new sets of transnational social relationships through different groups competing and cooperating These processes occur at a number of levels which are explored in different empirical settings Firstly at the level of governance multinational firms may develop conflicts between investors from different national contexts e g between the arms length orientation of Anglo Saxon institutional investors and the more committed orientation of investors in certain European and Asian contexts The tension between opening the firm up for foreign investors in order to have access to more and cheaper capital and the consequent effects on management strategy is explored in a number of chapters Secondly at the level of coordinating activities across different sites multinationals may encourage competition between plants in different countries as well as seeking to transfer best practices The result may be pressure on managers and employees in certain plants to give up traditional practices and employment rights Thirdly multinational firms operate in environments where other forms of coordinating international business activity may also occur e g cartels or the creation of international regulatory activity They therefore compete for the regulatory space in complex political environments that will enable them to prosper
