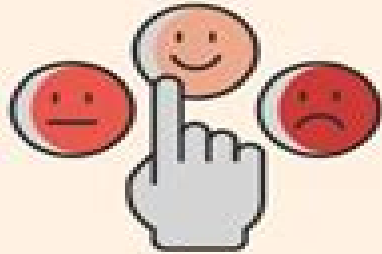

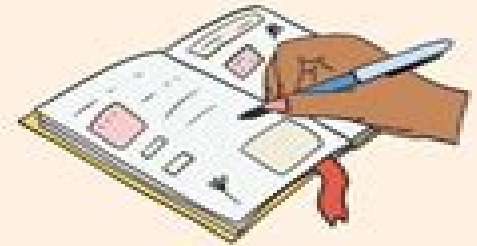

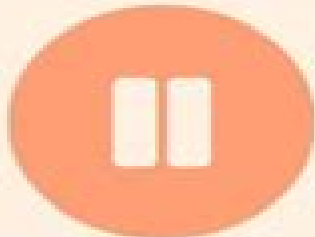

conference in Los Angeles on December 22 through 31 These messages were published under the title The Life and Way for the Practice of the Church Life 12 One message given at a meeting in Los Angeles on December 28 This message is included in this volume under the section title Fellowship concerning the Body of Christ There are indications that this message was one in a series of informal talks that Brother Lee gave during the conference held on December 22 through 31 Records of the other talks were not available for publication
