## Ethics

- Beneficence: Promote well-being.
- Nonmaleficence: Prevent/do no harm.
- Autonomy: Respect individual choices.
- Veracity: Communicate truthfully.
- Justice: Ensure fairness in care distribution.
- Fidelity: Uphold commitments.
- Advocacy: Support patient's decisions.
- Accountability: Accept responsibility for ones actions

## HIPPA

- Access Relevance: Healthcare workers should only access patient data related to their job.
- Password Security: Never share login information to prevent unauthorized entry.
- Focused Care: Avoid looking up patients not under your care.
- Physical Privacy: Keep patient records secure and prevent unauthorized access.
- Private Conversations: Refrain from discussing patient details in public areas.

## Torts

- Negligence: Not meeting nursing duties, endangering patients.
- Malpractice: Failing duties, causing patient harm.
- Assault: Verbal or implied threats.
- Battery: Physical contact causing injury.
- False Imprisonment: Unjustified restraint against patient's will.

## Patient Rights

- Right to respectful care
- Right to be informed about diagnosis, treatments
- Choose their provider
- Accept or refuse care
- Right to have privacy
- Right to their own medical records
- Right to be told about alternative care facilities
- Right to decisions of end of life care

## Consent

- Patients must consent to treatment
- Patients must be informed of the use of their health information
- When a patient isnt able to make decisions and the POA is unavailable, emergency law governs implied consent.
