GDP 14.1% with respect to exports and 10.4% regarding imports. Consequently, there is steady interest of foreign companies to form joint ventures in the People's Republic of China. But whereas in the 1980ies mostly the huge corporations were entering this market, nowadays more and more mid-sized companies, for instance from Germany, are forming joint ventures too. From the region Mittelfranken, for example, 320 businesses have developed ties with the People's Republic, a plus of 60% from 1996. Many foreign firms are considering entering joint ventures in China because this seems to offer the most attractive method for gaining access to the huge potential of the labour pool and market of China. Nonetheless, there are many warnings about the problems that have to be faced in order to establish a joint venture in China. Chief among these is the problem of differing management styles between Foreign and Chinese partners. Very little accurate information is available about Sino-Foreign joint ventures. An example is the wide disparity in the reports of the numbers of Sino-German joint ventures. It is not surprising, therefore, that the majority of research studies have focused on identifying the number and the internal structures of these joint ventures rather than on the practical problems of managing these businesses effectively.
