Objectif : Coordonner les politiques budgétaires des Etats membres de l'UEM.

Quand : Adopté au conseil européen d'Amsterdam les 16 et 17 Juin 1997.

Quoi : Premier instrument de coordination des politiques budgétaires des 15 états fondateurs. Cela permet d'éviter des déficits publics excessifs. Le PSC durcit les critères de Maastricht sur les finances publiques qui stipulent d'une part que les Etats membres évitent les déficits excessifs (à court terme, le budget peut être déficitaire, mais ce déficit ne doit pas dépasser 3% du PIB sous peine d'amende), et que d'autre part la dette publique doit être inférieure à 60% du PIB. Ce pacte comporte des dispositions préventives et des dispositions correctrices.

Partie préventive :

les objectifs budgétaires de moyen terme sont, depuis 2005, différenciés selon les Etats membres pour tenir compte du niveau d'endettement et de la croissance de chacun.

Partie corrective :

les « circonstances exceptionnelles » qui président au classement comme « excessif » ou non d'un déficit dépassant 3% prennent en compte un ensemble de facteurs et pas seulement le chiffre de la croissance (évaluation conjoncturelle, investissements publics, politiques d'incitation à la R&D et l'innovation); les délais fixés pour corriger le déficit excessif sont allongés afin de laisser le temps de prendre des mesures aux effets plus durables.

Le déficit excessif :

Si le Conseil considère qu'il y a déficit excessif, il adresse alors, sur recommandation de la Commission, une recommandation à l'État membre, en fixant un délai de 6 mois pour engager une action. Si l'État persiste à ne pas y donner suite, le mettre en demeure de prendre des mesures dans un délai déterminé. Aussi longtemps que l'État membre ne se conforme pas à sa décision de mise en demeure, le Conseil peut, sur recommandation de la Commission, prononcer des sanctions, notamment dépôt non rémunéré d'une somme variant entre 0,2 et 0,5% du PIB, en fonction du degré de dépassement de la valeur de 3% de déficit public. Ce dépôt est converti en amende au bout de 2 ans si le déficit excessif n'est pas comblé.

Programme de stabilité :

Institués par le Pacte de stabilité et de croissance, les programmes de stabilité (ou programme de convergence pour les États non membres de la zone euro), sont des outils de la surveillance multilatérale des politiques économiques et budgétaires qui permettent depuis 1999 l'examen de la situation macroéconomique et l'élaboration de recommandations adressées aux États membres par le Conseil. Ils ont lieux plusieurs fois par an (pluriannuels), ils sont actualisés annuellement et rendus publics. Ils sont transmis par tous les membres de l'Union européenne chaque année
