

# SUSPENDED SENTENCE

- A **suspended sentence** is a judgment that is passed but not carried out as long as the offender meets certain conditions set out by the judge;
- Suspended sentences can only be imposed for offences that have NO minimum punishment required by the *Criminal Code*;
- These are usually given for first-time or minor offences, or in the situation where the judge feels that the knowledge of the sentence alone is sufficient to keep the offender in line...
