international human rights instruments In the second part where I treated the trend of relative activism I noticed that this activism has two main expressions The first is that the Supreme Court read the constitution sometimes generously for the alien to ensure non discrimination on the basis of alienage and to secure procedural due process in deportation Nevertheless these constitutional guarantees remain widely precarious as they are conditioned with some presence related requirements and because of the inherently limited nature of these guarantees that could have never stopped the plenary power doctrine for example The second expression of this relative activism is that the Court tried to engage into statutory interpretations to promote alien s status And that was only feasible through the implementation of canons of statutory interpretation like the avoidance canon and rule of lenity in immigration among others In doing so the U S Supreme Court revealed to be relatively activist in the protection of aliens However this statutory protection had as main shortcomings that it produced unpredictable temporary and awkward solutions to the wider problems of immigration Nevertheless debate continues to prove the positive effect of this statutory protection as producing long term predictable solutions
