

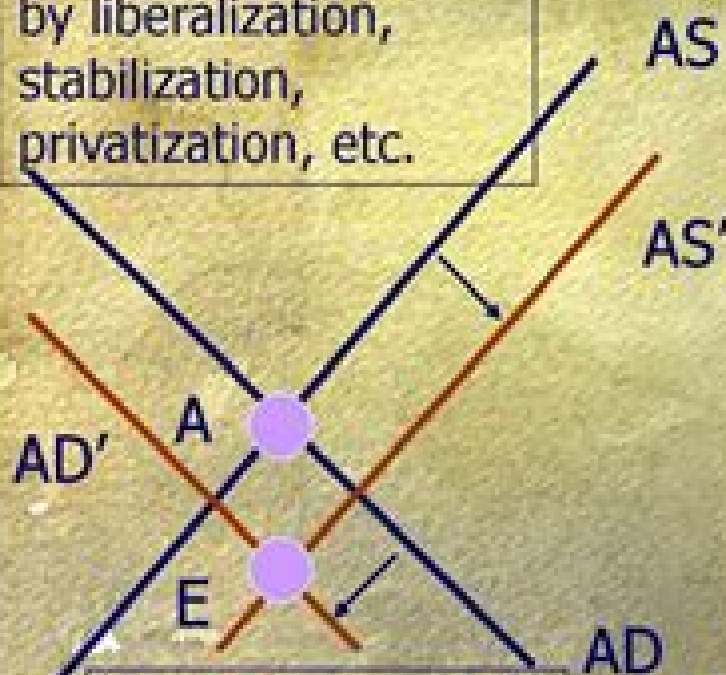
# Macroeconomic adjustment and structural reform
