

IRAS, QUALIFIED RETIREMENT PLANS, PENSIONS, AND ANNUITIES

A taxpayer must include distributions other than the taxpayer's cost (basis) from certain retirement plans or annuities in gross income. The IRS treats distributions of basis as a tax-free return of principal (not income). A loss may arise if the entire account is withdrawn and a taxpayer receives less than their cost basis.

TIP: The taxpayer should receive Form 1099-R reflecting information about the distribution, such as gross distribution, taxable amount, and federal income tax withheld (if any). A taxpayer filing a paper return should attach Form 1099-R only if federal income tax was withheld.

QUALIFIED RETIREMENT PLANS

The term *qualified retirement plan* has varied meanings within the tax code and IRS publications. In a broad sense, the term describes plans that qualify for favorable tax benefits such as tax deferral on contributions, investment gains, and earnings. As a result, plans such as IRAs, annuities, 403(b)s, and 457(b)s are at times described as qualified retirement plans for the application of specific rules and regulations.

There is, however, common usage of the term that identifies a specific subset of retirement plans. A qualified retirement plan is an employer-sponsored retirement plan that qualifies for special tax treatment under Section 401(a) of the Internal Revenue Code. These plans are sometimes called *ERISA qualified plans* because employer plans must adhere to the minimum standards set forth in the *Employee Retirement Income Security Act of 1974 (ERISA)*. Other terms used to describe these plans include a *qualified employee plan* or simply a *qualified plan*. To avoid confusion, we will not use this terminology to describe other types of plans that share similar tax advantages.

There are two basic kinds of qualified plans—defined contribution plans (e.g., a profit-sharing or 401(k) plan) and defined-benefit plans (e.g., a pension plan)—and different rules apply to each. Employers establish these plans and generally make contributions to fund the plan for the benefit of employees. Some plans also allow for elective deferrals of salary. This is where an employee can direct the employer
