It follows of course that the entities governed by a particular norm tell us nothing about the legal system to which that norm belongs. Instead, the distinction between international law and national law turns exclusively on whether the source of the norm in question is international or national in kind. Against the background of these insights, the book shows how present-day international lawyers continue to allow an idea which was never more than a scholarly invention of the 19th century to influence the interpretation and application of international law. This state of affairs has significant real-world ramifications as international legal rights and obligations of individuals and other non-state entities are frequently applied more restrictively than interpretation without presumptions regarding personality would merit.
