#### Introduction

- This Report on Dormant Accounts of Victims of Nart Persecution in Swiss Banks by the Independent Committee of Eminent Persons ("ICEP" or the "Committee") represents the culmination of a three-year investigation." The guiding principle of this endeaver has been to find as much of the truth about the fate of these victims' accounts, duting from before or during World War III, and their treatment by Swiss banks, as is feasible, given the passage of half a century. We are now confident that the Committee's investigation has produced a record of the past on this problem that is, in fact, as complete as is now possible.
- 2.
