The results indicate that such conditionality had a positive impact on tax revenue with strongest improvement felt on taxes on goods and services including the VAT. Revenue conditionality matters more for low income countries particularly those where revenue ratios are below the group average. Moreover revenue conditionality appears to be more effective when targeted to a specific tax.
