have based their claims for Henday's importance as an explorer trader and observer of Native cultures on a poorly edited transcript of the 1782 text They have been unaware or careless of the journal's textual ambiguity A Year Inland presents all four copies for the first time together with contextual notes and a commentary that reassesses the journal's information on plains geography people and trade
