- ❑ In 1985, Gorbachev began a reform program based on two principles: Perestroika (restructuring of economic and political life) and Glasnost (policy of openness under which the government increased its tolerance of dissent and freedom of expression)
- ❑ The Russian government is now struggling toward democracy and economic reform; it has a multi-party system
