Pijnenborg, 1995 In the end death comes to us all This reality has not changed during centuries of attempting to unravel the mysteries of life and death Even today death is the most unescapable event in each human life Life and time before death however have altered considerably At least two changes are responsible for this The first is that over the past hundred and fifty years man has succeeded in changing his condition in such a way that in the well developed countries average life expectancy has doubled The strongly reduced perinatal and infant mortality have caused death to disappear almost completely from daily life in the Netherlands A second Important development is of much more recent date basically dating only from after World War Ii the development of modern medicine Medical practice today is increasingly able to assist in curing the sick in making life bearable for the sick and extending life for a shorter or longer period of time In other words death still comes to everyone but the time at which this happens isoften partly determined by decisions whether to stop or to continue treatment Obviously this does not hold for all deaths People still die from accidents or from acute fatal diseases such as acute myocardial infarction In all non sudden deaths however patient and physician are involved in a shorter or longer disease process A considerable difference compared with the situation existing over one hundred years ago when In some municipalities more than half of all deceased had no physician s assistance during their preceding disease Now that medicine can offer so much in terms of
