– An international treaty that limits states' rights to engage in "trade protection" 1945 -> Present

■ Promotes:

- "**Non-Discrimination**" : Principle that no member of an organization should be excluded from the benefits that one member state extends to another.
- "**Reciprocity**": Complementary or mutual behavior between two or more actors; view that mutual liberalization of trade barriers would be beneficial to all parties
