Medicare – Inpatient Prospective Payment System (IPPS) Defined

- IPPS system was effective October 1983
- Applies to acute care hospitals
- What does IPPS mean?
 - A fixed, prospectively determined amount for each inpatient hospitalization based on Medicare severity diagnosis-related groups (MS-DRGs);
 - One of the purposes of the IPPS system was to encourage hospitals to operate more efficiently;
 - However, hospitals also run the risk for higher costs under IPPS as well
- IPPS is based on the law of averages cost of some inpatient stays under IPPS may be greater or less than the IPPS payment
