Factual and empirical problems lead to the formation of *Informal* networks of agreements, principles, rules, norms and decision-making procedures that enhance the Institutionalization of the political management of conflicts and interdependence problems and mitigate conflicts through means of (legal) regulation and control. Thus, they contribute to the civilization of the relations among the actors and stabilize the predictability of the actors' decisions/ actions. Regimes support, supplement, undercut or overarch the spheres of competence of the traditional society of states and integrate the cooperation of actors into a complex multi-level system of political or socio-economic decision-making processes that do account for the actors' regulatory interests in each particular issue area. Within that context, the EU could be conceived of as a relatively effective international regime constructed for the management of problems of *economic* interdependence by means of negotiated *political* coordination processes.
