Punitive Medicine Aleksandr Podrabinek, 1980 In the decade since the American Psychiatric Association condemned the use of psychiatric institutions for the suppression of political dissent the practice has continued to spread in the Union of Soviet Socialist Republics Alexander Podrabinek wrote this account after working as a medical assistant and pursued his research while undergoing police harrassment He has since been arrested and is in exile in Russia The manuscript was smuggled out translated and published in this country Podrabinek recounts the historical absence of a civil liberties tradition in Russia asserting that compulsory psychiatric treatment was not needed in Czarist or early Communist times as liquidation was more efficient Nonetheless shortly after the revolution of 1917 punitive hospitalizations began and a network of special psychiatric hospitals developed to confine thousands of dissidents and socially dangerous individuals Punitive Medicine contains many quotations from former inmates or patient prisoners photographs of hospitals and ex inmates and also pictures
