Depending upon the size and nature of the organization, the duties of Purchasing and Inventory Clerks may either be distinct or overlap in function.</i>
Position Development	Progression to supervisory and management positions is possible through experience and with additional training.
Required Qualifications:	(Education, Training, Related Work Experience)
Education	Purchasing and Inventory Clerks at minimum require a high school diploma or equivalent.
Training	Required training includes purchasing training, procurement and inventory management training, and the ability to build, operate, and maintain a computerized inventory and purchasing system.
Related Work Experience	Previous supply chain work-related skill, knowledge, or experience specifically in purchasing and/or inventory systems is usually needed.

Purchasing and Inventory Clerks perform some or all of the following tasks	<ul style="list-style-type: none"> • Prepare and/or review purchase requisitions/orders as required • Source price quotations and prepare purchase requisitions/orders • Process purchase requisitions/orders within purchasing authority • Monitor inventory levels and reconcile physical inventories with records • Generate and/or review inventory reports • Match purchase requisitions/orders with invoices and forward to accounts for payment processing • Expedite and follow up with suppliers to schedule deliveries, resolve material, value discrepancy, outstanding and overdue delivery of orders, warranty claims and damage, and return of materials
