The result is an international system in which national economies are closely linked through international capital markets as well as trade in goods and services Using data from the major industrial countries Bosworth highlights the process by which changes in domestic rates of saving and investment lead to changes in interest rates exchange rates and trade balances He first examines why national saving and investment have fallen throughout the industrialized world He then focuses on how exchange rates respond to trade imbalances and considers whether the wide fluctuations in exchange rates are a cause for concern or simply an integral part of the international adjustment to the divergent patterns of national saving and investment
