specified for SHYSTER and its operation has been tested in each of those domains Testing of SHYSTER in these four domains indicates that it is exceptionally good at predicting results and fairly good at choosing cases with which to construct its arguments SHYSTER demonstrates the viability of a pragmatic approach to legal expert system design
