prices cannot persuade everyone that the results are not my view are the only ones that can solely monopoly driven Market forces in answer my question is New Zealand Post a commercial organization We need the test of free and open competition to see whether we've got the business formula right Before advancing this argument which in essence is the case for deregulation it may be useful to distinguish between market behavior and Post behavior

Health Care Policy and Regulation Thomas A. Abbott III, 2012-12-06 5 care reforms Part II Price Regulation The second part of this volume examines the role of price regulation in controlling health care costs It contains three chapters In chapter seven I examine the alternatives for regulating pharmaceutical prices In chapter eight Jack Hadley examines the impact of various forms of hospital price regulation while in chapter nine Mark Pauly examines the role of price regulation in controlling physician fees Chapter seven focuses on the issue of regulating pharmaceutical prices There are two key issues examined in this paper First is there a clear need for price regulation and second can price regulation work in this industry In response to the first

question I come to the conclusion that the proponents of price regulation have not really proven their case. Although the financial returns in the pharmaceutical industry have been slightly higher than expected during the 1970s and 1980s there is not overwhelming evidence of price gouging or excessive profits on the part of the industry. In response to the second question the answer is clearly no. The traditional approaches to price regulation will not have the intended effect of eliminating excess profits from the industry while maintaining the incentives for research and development. First rate of return regulation the most natural approach would result in many adverse incentives including excessive investment in research and development in order to inflate the rate base used to calculate the allowable returns.

X-Efficiency: Theory, Evidence and Applications Roger S. Frantz, 2012-12-06 My interest in X Efficiency XE dates back to 1978. At the time I was writing the dissertation for my Ph.D. at Washington State University. My dissertation was concerned with the role of attitudes in the school to work transition among young men. I was advised by Professor Millard Hastay a member of my committee to look at Leibenstein's new book *Beyond Economic Man*. One of the things that caught my attention was his behavioral description of selective rationality. It seemed that Leibenstein's behavioral description of a selectively rational individual was very similar to what psychologists such as Abraham Maslow were reporting as being the product of a particular motivational system. In other words I was impressed with the idea that what Leibenstein was referring to as X inefficiency was being discussed by psychologists as the way it often is. So from the beginning I always considered the concept of X inefficiency to be a valuable one for understanding human behavior. I have since come to believe that this is particularly true when considering behavior in non market environments i.e. within the firm. Work on this book however can most realistically said to have started with work which I began in 1982 while I was a Visiting Scholar at Harvard University. Professor Leibenstein suggested that I consider how some empirical evidence which was being cited as evidence for the role of property rights might also be consistent with XE theory. The consistency in both directions is considerable.

Regulating Power: The Economics of Electricity in the Information Age Carl Pechman, 2012-12-06 Modern industrial society functions with the expectation that electricity will be available when required. By law electric utilities have the obligation to provide electricity to customers in a safe and adequate manner. In exchange for this obligation utilities are granted a monopoly right to provide electricity to customers within well defined service territories. However utilities are not unfettered in their monopoly power. Public utility commissions regulate the relationship between a utility and its customers and limit profits to a fair rate of return on invested capital. From its inception through the late 1970s the electric utility industry's operational paradigm was to continue marketing electricity to customers and to build power plants to meet customer needs. This growth was facilitated by a U.S. energy policy predicated upon the assumption that sustained electric growth was causally linked to social welfare. Lovins 1977. The electric utility industry is now in transition from a vertically integrated monopoly to a more competitive market. Of the three primary components generation transmission and distribution of the traditional vertically integrated

monopoly generation is leading this transformation The desired outcome is a more efficient market for the provision of electric service ultimately resulting in lower costs to customers This book focuses on impediments to this transformation In particular it argues that information control is a form of market power that inhibits the evolution of the market The analysis is presented within the context of the transformation of the U S

The Crisis in Telecommunications Carrier Liability

Barbara A. Cherry,2012-12-06 My curiosity with the economic efficiency and social benefits of provisions used by telecommunications carriers to limit their liability to customers for damages arising from service interruptions and network outages is a longstanding one It began with the changing state regulatory environments in the late 1980 s while representing AT T as an attorney before numerous state legislatures in the Midwest As telecommunications carriers faced the ramifications of deregulation several legal consequences came to the fore One important consequence was the impact of changing regulatory rules and requirements on the carriers abilities to continue to limit their liability for damages to customers in a non tariffed world As a result one of my responsibilities while employed by AT T was to seek legislative relief in some state jurisdictions which would enable the continued use of limited liability provisions notwithstanding other deregulatory developments in the industry In my capacity as an attorney I succeeded in this task in the few jurisdictions for which I was given the charge However as an economist these efforts piqued my interest regarding the economic effects of such limited liability provisions on consumer interests What liability rules for the industry would really better serve general societal interests As my career evolved which involved returning to graduate school to pursue my Ph D and becoming the Director of Public Policy Studies at Ameritech I had the opportunity to pursue interdisciplinary research in telecommunications policy issues

things the enormity of regulation in the u s economy and the relative absence of economic research into the macroeconomic consequences of those regulations While I would have readily granted the idea that many economist knew more about regulation than I did I would have thought my knowledge of regulation to be at least up to the average economist s My graduate training in the early to mid 1980s included special attention to the field of public choice and related topics all of which occasionally explored regulatory topics Moreover I had at least a passing knowledge of the debates concerning deregulation in the late 1970s and early 1980s Because of this my own ignorance of regulation s actual expanse and its aggregate consequences startled me and heightened my interest in expanding empirical research into regulation as a macroeconomic influence The more I thought about graduate macroeconomics classes and texts the more that I realized the exclusion of regulation as a macroeconomic topic in spite of its massive scale and far reaching tentacles
