This miscarriage of justice not only denied Emily her rightful place with her family but also reflected systemic failures with at least 80 similar cases slipping through the cracks. The 2012 Final Report from the Council of the Inns of Court COIC Disciplinary Tribunals and Hearings Review Group sought to address these deep-seated issues. Under the leadership of Brigadier Tony Faith CBE, 85 recommendations were implemented to restore confidence in the administration of justice. Yet despite these reforms, the wrong done to Emily remains unrectified, leaving her family in a limbo of unfulfilled promises. This is one man's harrowing story of frustration and determination as he battled for access rights to his young daughter following the death of their mother in East Sussex. Incredibly, this journey was over ten years with countless communications ending in the PHSO. The costs of this are estimated at a million pounds. What should have been a simple dispute somehow resulted in a genuinely good man with true family values being slandered by the family courts who could not even press the start button on the stenograph to record the hearings.
