

#### The firm as a decisionmaker

The firm is a decisionmaker on "the other side" of the economy (i.e. supplying goods to consumers), whose decisions are guided by the **ultimate objective of profit maximisation**. The firm as a decisionmaker is also an important component for most theoretical models, e.g. modelling a certain firm's decision to predict behaviour (and its consequences), and for Macroeconomic modelling.
