However, no analysis, no matter how thorough of a borrower's creditworthiness, can be enough to ensure that a loan is completely free of risk. You will learn the methods used by lenders to qualify loan applicants and how lenders qualify the property to be mortgaged. This involves a thorough and accurate property valuation using the sales comparison or cost approach for residential property and a cap rate or discounted cash flow analysis for investment property.
