The act also covers issues such as auditor independence corporate governance internal control assessment and enhanced financial disclosure The act was approved by the House by a vote of 423 in favor 3 opposed and 8 abstaining and by the Senate with a vote of 99 in favor 1 abstaining President George W Bush signed it into law stating it included the most far reaching reforms of American business practices since the time of Franklin D Roosevelt Debate continues over the perceived benefits and costs of SOX Opponents of the bill claim it has reduced America's international competitive edge against foreign financial service providers saying SOX has introduced an overly complex regulatory environment into U S financial markets Proponents of the measure say that SOX has been a godsend for improving the confidence of fund managers and other investors with regard to the veracity of corporate financial statements Sarbanes-Oxley Act in Perspective Harold S.
