

# Powers and Responsibilities of Charter Schools



- Under Connecticut law, state and local charters:
  - Have the power to sue and be sued;
  - Have the power to purchase, receive, hold and convey real and personal property for school purposes;
  - Have the power to borrow money.
  
- A “charter” is defined as a “contract between the governing council of a charter school and the State Board of Education that sets forth the roles, powers, responsibilities and performance expectations of each party to the contract.”
