DIVORCE

- In England and under Christian law, divorce was not an available option
- **Annulment of marriage** (marriage declared as void ab initio) and **judicial separation** was legal
- Changes made through **Matrimonial Causes Act, 1857** allowed divorce
- But traditional view of English courts on divorce was some kind of a closed one
- **Le Mesurier vs. Le Mesurier**, 1895
- Jurisdiction to try divorce case is given with the courts, where husband domiciled at the time of institution of suit
- Strict adherence to this rule created some problems for deserted wife
- Husband deserted wife – Fled to one another country – Wife has no other option other than going for a redressal from where the husband is living
