freedom of expression and freedom of worship to more disputed cases such as welfare rights for instance the idea of a human right to health His goal is a substantive account of human rights an account with enough content to tell us whether proposed rights really are rights Griffin emphasizes the practical as well as theoretical urgency of this goal as the United Nations recognized in 1948 with its Universal Declaration the idea of human rights has considerable power to improve the lot of humanity around the world We can't do without the idea of human rights and we need to get clear about it It is our job now the job of this book to influence and develop the unsettled discourse of human rights so as to complete the incomplete idea
