

Probability and Logic

- Probability can be viewed as a generalization of propositional logic
- $P(a)$:
 - a is any sentence in propositional logic
 - Belief of agent in a is no longer restricted to *true*, *false*, *unknown*
 - $P(a)$ can range from 0 to 1
 - $P(a) = 0$, and $P(a) = 1$ are special cases
 - So logic can be viewed as a special case of probability
