Baldwin, 2014-01-02 The relationship between a head of government head of the executive branch and a nation's parliament or legislative assembly the legislative branch has long been the focus for comment and analysis for example has the prime minister in the United Kingdom come to a position of dominance at the expense of the power of parliament Does the American president stand head and shoulders above Congress Is a French president master of the system Need the Russian president pay attention to the Duma What of the position in other parliamentary and presidential systems In this book Baldwin seeks to provide answers and does so by drawing upon the knowledge and expertise of an international group of scholars whose essays advance our knowledge of the subject This book was previously published as a special issue of the Journal of Legislative Studies *Shaping the Democratic Order* Anna van der Meer Krok-Paszkowska, 2000 *Democracy in Poland* Anna Gwiazda, 2015-07-24 This book assesses the quality of democracy in Poland from the collapse of communism in 1989 up to the 2011 parliamentary election It presents an in depth empirically grounded study comparing two decades of democratic politics Drawing on democratic theory and comparative politics the book puts forward an evaluation of democracy based on four dimensions representation participation competition and accountability The book is an important contribution to debates on the performance of the new democracies in Central and Eastern Europe where some scholars argue that there is a democratic crisis that after a period of democratic progress most of these countries are experiencing democratic fatigue and that their democratic performance is poor However the Polish case shows that democracy is not in crisis in fact the quality of democracy in Poland has improved The book shows that democratic quality stems from good democratic institutions Moreover the Polish case shows useful lessons that can be learnt by democratic reformers in countries that are undergoing the transition to democracy or are aiming to consolidate their democratic systems It concludes that effective accountability good representation and stable competition are vital

In Pursuit of Liberalism Rachel A. Epstein, 2008-09-29 Though the fall of the Soviet Union opened the way for states in central and eastern Europe to join the world of market oriented Western democracies the expected transitions have not been as easy common or smooth as sometimes perceived Rachel A Epstein investigates how liberal ideas and practices are embedded in transitioning societies and finds that success or failure depends largely on creating a social context in which incentives held out by international institutions are viewed as symbols of an emerging Western identity in the affected country Epstein first explains how a liberal worldview and institutions like the European Union World Bank the International Monetary Fund and the North Atlantic Treaty Organization go hand in hand and why Western nations assume that a broad and incremental program of incentives to join will encourage formerly authoritarian states to reform their political and economic systems Using Hungary Poland Romania and the Ukraine as case studies she demonstrates the limits of conditionality in the face of national social perceptions and elucidates the three key points around which a consensus within

the state must emerge before international institutions can expect liberalization domestic officials must be uncertain about how changing policies will affect their interests the status of international and domestic institutions must not be in jeopardy and the proposed policies must seem credible In making her case Epstein cleverly bridges the gap between the rationalist and constructivist schools of thought Offering new data on and fresh interpretations of reforming central bank policies privatizing banks with foreign capital democratizing civil military relations and denationalizing defense policy In Pursuit of Liberalism extends well beyond the scope of previous book length studies

The Acceptance of Party Unity in Parliamentary Democracies David M. Willumsen, 2017-09-01. Despite the central role of policy preferences in the subsequent behaviour of legislators, preferences at the level of the individual legislator have been almost entirely neglected in the study of parliaments and legislative behaviour. The main reason for this is the difficulty of obtaining measures of legislator preferences that are not based on their behaviour. This book explores direct measures of policy preferences through parliamentary surveys. Building on this, the book develops measures of policy incentives of legislators to dissent from their parliamentary parties and demonstrates that preference similarity amongst legislators explains a very substantial proportion of party unity, yet cannot explain all of it. Through a quantitative analysis of the attitudes of legislators to the demands of party unity and what drives these attitudes, the book argues that the reason for the difference between observed unity and the levels of unity which can be explained by preference similarity among legislators is the conscious acceptance by MPs that the long-term benefits of belonging to a united party, such as increased influence on legislation, lower transaction costs, and better chances of gaining office, outweigh the short-term benefits of always voting for their ideal policy outcome. The volume reinforces this argument through the analysis of both open-ended survey questions as well as survey questions on the costs and benefits of belonging to a political party in a legislature.

EU Enlargement and the Failure of Conditionality Dimitry Kochenov, 2008-01-01. Among the criteria for accession to the European Union are democracy and the Rule of Law. In the insightful analysis offered by the author of this book, these concepts, while admirable and even necessary criteria in principle, are almost impossible to measure, and any judgement grounded in them will always be difficult to justify. In his words, by including analysis of democracy and the Rule of Law within the field of the EU enlargement law, the Union entered an unstable terrain of vague causal connections and blurred definitions. Dr Kochenov addresses this problem by proceeding as follows:

1. Outlining EU enlargement law in general, including the principle of conditionality and the role

played by the analysis of democracy and the Rule of Law in enlargement preparation 2 Focusing on the role actually played by the monitoring of democracy and the Rule of Law in ten candidate countries scrutinizing the way the EU used the legal tools and competences outlined in its enlargement law The book adopts the EU's own understanding of democracy and the Rule of Law as derived directly from the substance of the numerous legal and political instruments issued by the Community Institutions and especially the Commission in the course of the pre accession process In this way it demonstrates the actual as opposed to the officially announced role played by the assessment of democracy and the Rule of Law in the candidate countries in the regulation of enlargement Many formidable inconsistencies in the application of the conditionality principle are thus laid bare This leads the author to a series of recommendations on policy and procedure that he demonstrates could be profitably applied to the regulation of current and future accessions using the Commission's own structure of monitoring pre accession reforms in the three areas of the legislature executive and judiciary in candidate countries The probity and soundness of these recommendations firmly grounded as they are in the actual pre accession monitoring and its consequences for the pre accession progress of ten Eastern European countries admitted to the EU in 2004 and 2007 will greatly interest policymakers and scholars concerned with the future of European integration **Post-Communist and**
