

## Book reviews

*Russia's Political Hospitals.* By Peter Reddaway and Sidney Bloch. (Pp. 510; illustrated; £6.95.) Gollancz: London, 1977.

*Psychiatry on Trial.* By Malcolm Lader. (Pp. 102; 80p.) Pelican: Harmondsworth, 1977.

As the first of these two timely books makes clear, it is one of the sad historical ironies that the political misuse of psychiatry in the USSR roughly coincides with the post-Stalin attempt to put some substance into the concept of 'socialist legality'. The system whereby people would simply disappear via the grinding mills of the Gulag or the firing squads became unacceptable to Stalin's successors, who were mostly lucky survivors of that system. In Russia, which has almost always been deprived of peaceful outlets of protest, anarchy is as much part of the national heritage as the acquiescence of the all-suffering masses. Nationalist sentiment, bad harvests, economic backwardness, contact with the West, and ideological dissidence, all contribute to hidden and potentially explosive tensions. Against this threat the authorities use a two-pronged weapon: a vigilant, repressive, enormously extensive State apparatus, and the creation of a myth surrounding the revolution and its theories. The first is responsible for the organization of repressive organs, including mental hospitals, whereas the other gives a rigid measure of normality of conduct in whose name dissidents can be found insane. It becomes a function of the leaders of the Soviet psychiatric profession to clothe this latter process with a scientifically acceptable terminology. A whole set of psychiatric terms is given prominence or even created *de novo*. To the Western psychiatrist, whatever his criteria for schizophrenia, concepts like 'ideas of reformism', 'messianic delusions', 'loss of critical faculties' are not admissible as a basis for diagnosis, let alone for compulsory treatment. It is quite clear that in order to function as a member of the psychiatric establishment the Soviet psychiatrist undergoes a split which by long training does not even seem to strike him as strange, let alone give rise to scruples. Nowhere is this split more crudely illustrated than by a remark made by Dr Serebryakova, the administrative head of psychiatric services, which is quoted in *Russia's Political Hospitals*: 'Victor Fainberg, facing a psychiatric commission of which she was a member, mentioned a certain Lysak who had been kept in the Leningrad security hospital for 13 years - 'Lysak!' she exclaimed, 'that one is really mentally ill'.

In the fifties an addition to the revolutionary myth

was created by the liberalizing hand of Khrushchev. Under him socialism was depicted as a system of social relations in which crime was impossible. As the terms 'capitalist remnants', 'Trotskyite wreckers' and 'bourgeois subversion' lost their appeal as explanations for crime, the equating of crime with madness had a certain internal logic: but such procrustean views are known to breed dangerous absurdities, well illustrated by Soviet psychiatric jargon relating to dissidents.

In 1966 the trial of Daniel and Sinyavsky, which took place under a glare of publicity in the Soviet Union and the West, produced a genuine revulsion among a minority of Soviet intellectuals. Civil rights movements sprang up and evidence was collected of infringements of civil rights, including the misuse of psychiatry for political ends. The 'advantages' of the psychiatric disposal of dissidents were thrown into relief: an absence of publicity, a near total denial of legal rights, and the minimum of judiciary procedure. This is an ideal way of coping with a threat of dissent where this is considered to be so potentially damaging. A few psychiatrists held out against such clear infringements of human rights, like Professor Detengof who ruled General Grigorenko sane in 1969 and Dr Semyon Gluzman who criticized those psychiatrists who ruled him insane and, as is known, paid for his 'crime' with a 7-year term of imprisonment followed by 3 of exile. But there was a sufficient body of senior doctors, some of them of high education and urbanity like Professor Snezhnevsky, and others of lesser stature like Professor Georgii Morozov, who lent themselves to the task of defending the system at the expense of professional decency. One has only to recall the deliberate falsification of the Plyushch diaries and the repeated recommendations for special hospital treatment in the absence of any security requirements to appreciate the ruthlessness of these men.

In 1971 two events occurred which galvanized Western psychiatric opinion: Bukovsky, during one of his rare intervals of freedom outside prison or special psychiatric hospitals, managed to collect the psychiatric reports on a number of dissidents and sent them to the World Psychiatric Association for consideration at their Mexico City meeting in 1971. It was an extraordinary feat and Bukovsky naturally refuses to reveal how it was done. It is reasonable to suppose, however, that many of the collaborators were psychiatrists themselves. This is confirmed by Fainberg, whose literary and political activities while a detainee in a psychiatric hospital were only
