

## RULES

### AIM OF THE GAME

To score points, look at the letter dice and try to come up with the most words in one shot. Roll - before the time runs out!

### BEFORE THE GAME

Give each player a pencil and a sheet from the pad.

### HOW TO PLAY

1. The oldest player rolls the dice and turns the sand timer.
2. Now all the players try to form three words from the letters on the dice and write them in their sheet before the time runs out. The letter dice counts as any letter. Long right? Just remember these rules:
  - Write just one word on each row.
  - You can use each letter the letter dice shows only once for each word.
  - You can write a word on any row on your sheet, but you have to use all the squares in that row.
  - Don't play the words aloud during the round, and don't peek at everyone else's words!
3. When the sand has run out is the time! The round is over. Now the players compare the words they just wrote and mark down their scores.
  - For each word on one shot write on this round or the previous round, you score the maximum points on that row.
  - If two or more players have written the same words on the same round, neither one of them scores points for it. Mark 0 points on that row.

- If a player has written 3 word sentences that write on a previous round, the score for the previous round remains the same, but none for the word on this round is 0.
- The scores for the round are marked on the sheets next to the words. If you cannot think of three words before the time is up, write a score of 0 next to as many rows as you missed. This way, each player can check next on each round.
- If someone has written more than three words, they are still only scored for three. The extra words are disqualified, and scored 0 points.

### PLAYING A NEW ROUND

After the scoring, roll the dice again, and play the new round as above.

### END OF THE GAME

When you have played four rounds, the player with the highest score wins. If the game ends in a tie, the winner is the player who got the highest score on the final round.

### 2-PLAYER GAME

If there are only two players, play as above, but only play three rounds and write four words on each round. In a 2-player game, the players end up with different scores, because there is less time to come up with words.
