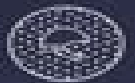

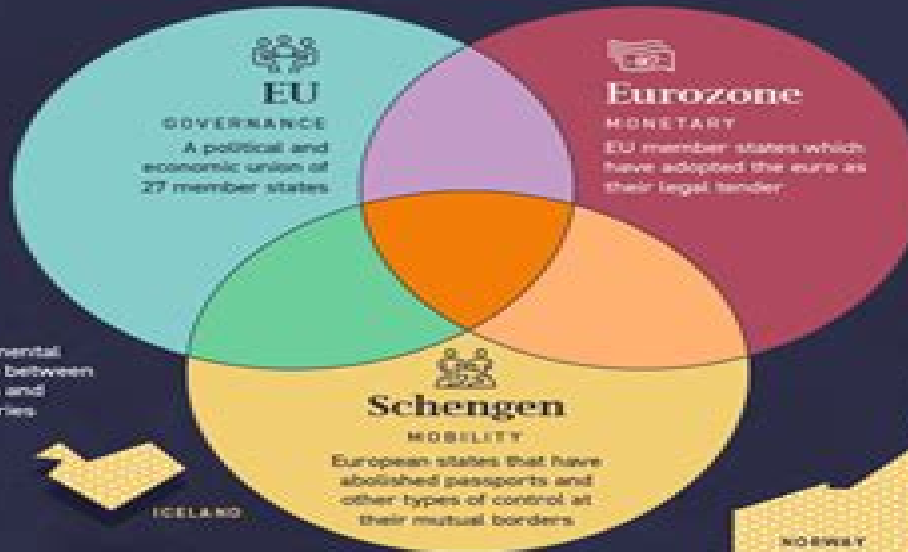
The **European member states** are countries mainly in Europe that are part of one or more of the four major treaty groups, namely the European Union, NATO, Schengen and Eurozone.

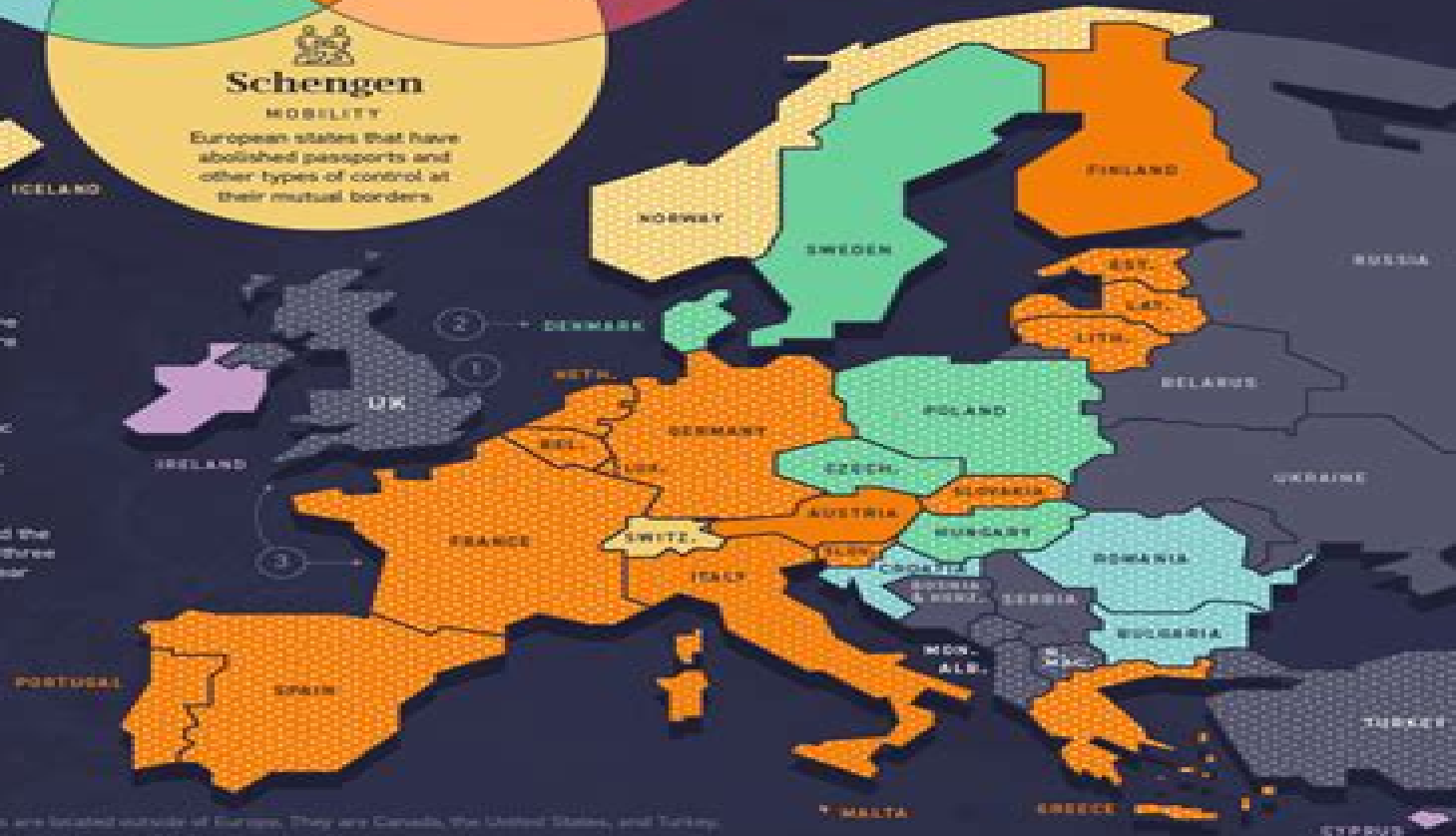
