#### 1. APPOINTMENT AND AUTHORITY

The Principal hereby appoints the Attorney-in-Fact as his or her true and lawful agent and attorney, with full power and authority to act on the Principal's behalf as outlined in this POA.

#### 2. SPECIFIC POWERS

The Principal grants the Attorney-in-Fact the power and authority to conduct the following on his or her behalf:

- a. Real Property Transactions: Purchase, sell, exchange, lease, rent, improve, repair, encumber, and manage any interest in real property.
- b. Personal Property Transactions: Purchase, sell, exchange, lease, rent, improve, repair, encumber, and manage any tangible or intangible personal property.
- c. Banking and Financial Transactions: Conduct banking transactions; safe deposit box transactions; lending or borrowing transactions; business operating transactions; insurance and annuity transactions; government benefits; retirement plan transactions; tax matters; claims and litigation; personal and family maintenance; benefits from military service; and records, reports, and statements.
- d. Estate Transactions: Establish, modify, or terminate trusts; claim, deliver, receive interest, dividends, or proceeds of trust or estate.
- Legal and Litigation Matters: Commence, prosecute, abandon, defend, submit to arbitration, settle, propose or accept a compromise with respect to, or waive any rights with respect to any claim existing in favor of or against the Principal.
- Healthcare Decisions: Make any lawful healthcare decisions on behalf of the Principal in the event of the Principal's incapacity.

#### 3. NON-DELEGATION OF POWERS

The Attorney-in-Fact may not delegate these powers to any third party without the prior written consent of the Principal.

#### 4. DURATION

This POA becomes effective immediately upon execution and shall continue in effect indefinitely, or until the Principal's death, or until expressly revoked by the Principal.

#### 5. REVOCATION
