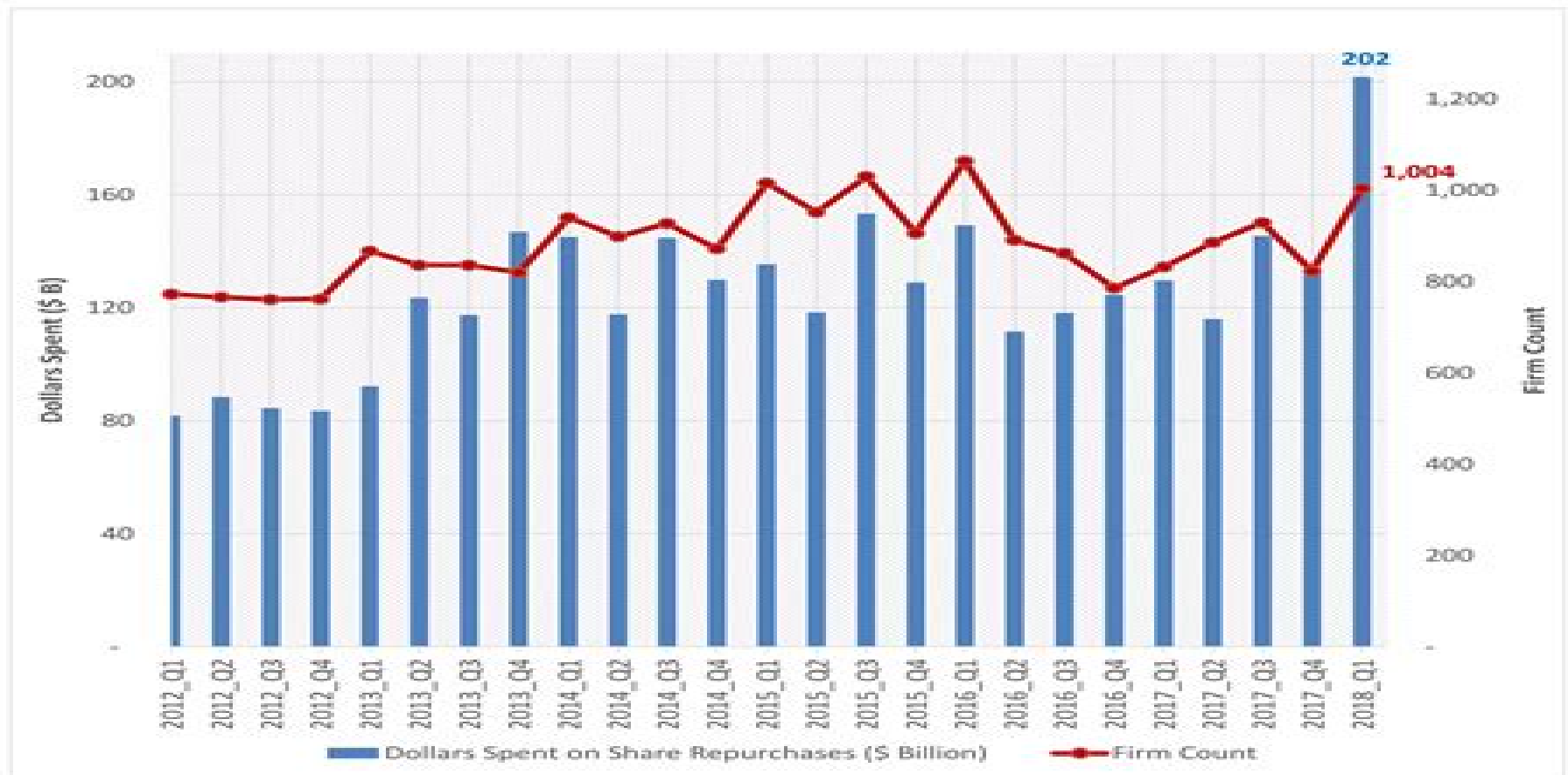


Dollars Spent on Share Repurchases By Quarter
