

# Think, Pair, Share: Will Shari'ah law be the same everywhere?

There are five different schools of interpretation of sharia: one in the Shia tradition of Islam and four in the Sunni tradition. Middle Eastern countries of the former Ottoman empire favour the Hanafi doctrine and north African countries prefer the Maliki doctrine; Indonesia and Malaysia follow the Shafi'i doctrine; Saudi Arabia adheres to the Hanbali doctrine; and Iran follows the Shia Jaafari school. All the schools are similar, but some take a more literal approach to texts while others prefer a loose interpretation.

## The many faces of Sharia

When many non-Muslims think of the Sharia, they often conjure up an image of a public beheading or amputation.

However, Sharia differs enormously in its various implementations throughout the Islamic world.

Saudi Arabia has long practised a harsh form of the law, under which murderers and drug smugglers may be executed, thieves lose their hands, and adulterers may be stoned.

But as *Islamic Republic of the Maldives* in London explains, this does not offer a satisfactory understanding of the Sharia.

"Some offences require harsher penalties, but of course, it's not the case that everyone in Saudi Arabia is walking around with a sword or other form of weapon. Nor are they all in fear of being put to the sword or being beheaded," he says.

Other Muslims add that Saudi Arabia's judges are the only branch of state power which the country's royal family has no control, as Sharia makes them heavily independent of all but their religious obligations.

Yet, as the *Islamic Republic of the Maldives* explains, not all Muslim countries prevent politics from interfering with the purity of Sharia.
