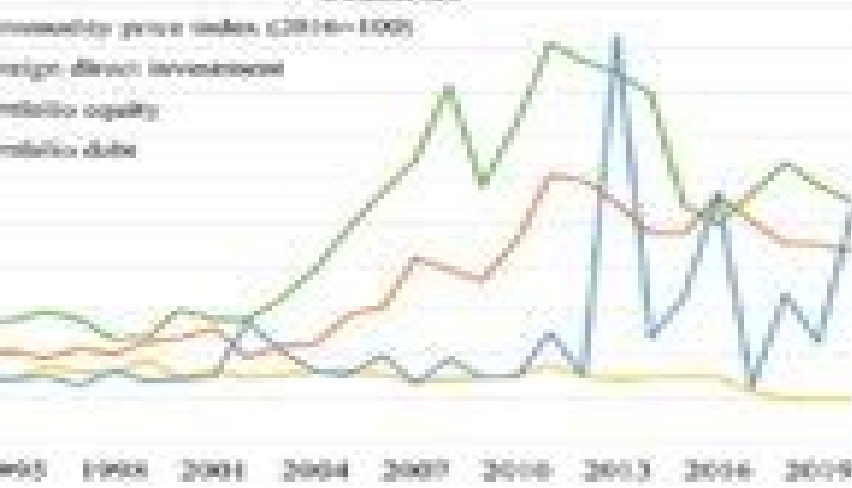


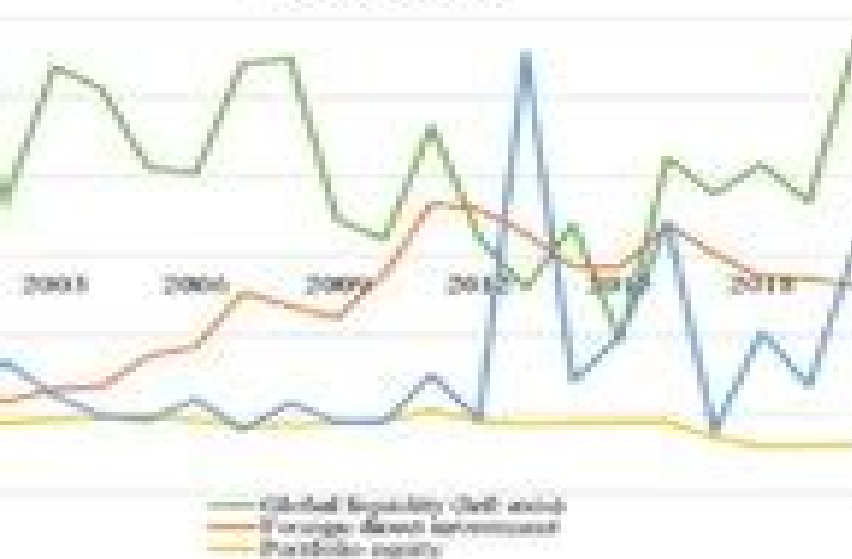

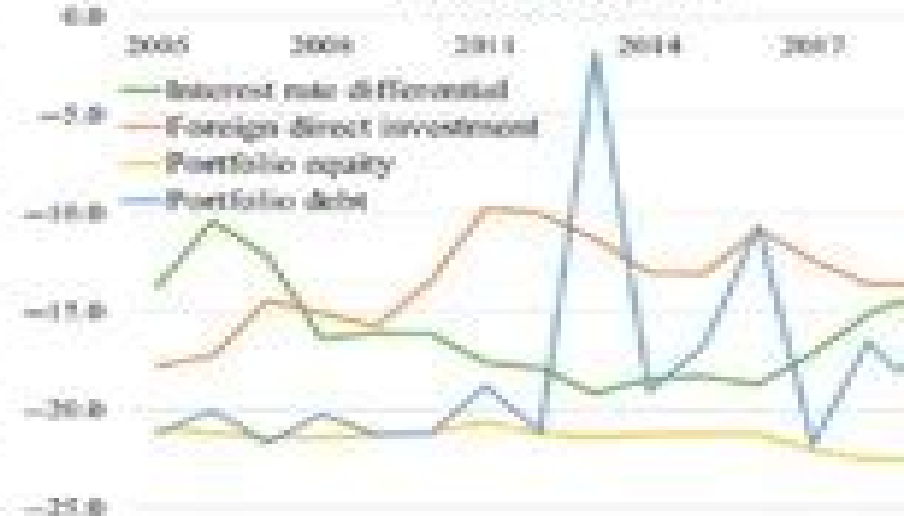
VIX and Capital Inflows to Low-Income SSA countries
