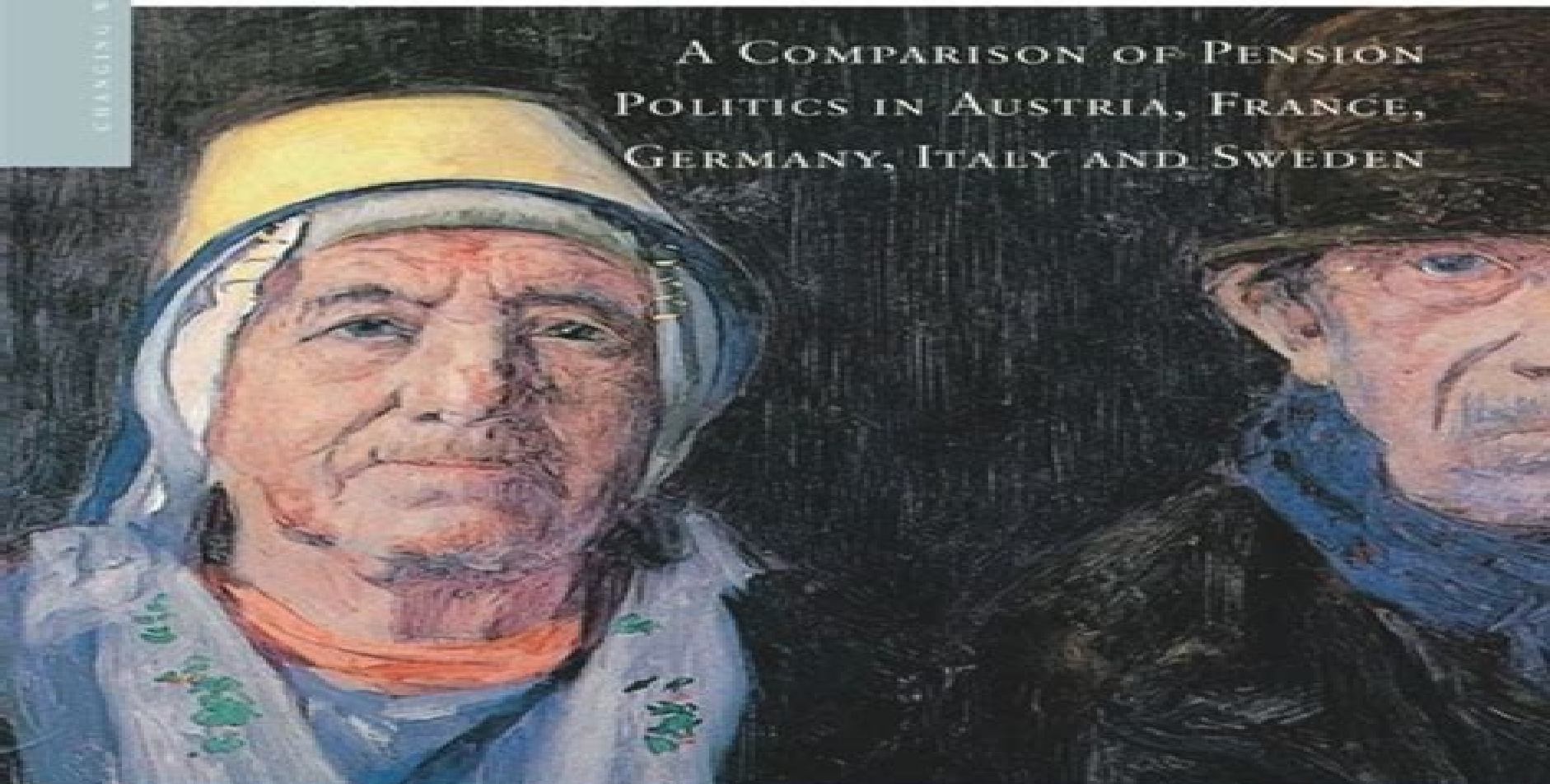

to obtain support from major interest groups corporatist arena on the one hand and from political parties electoral arena on the other The core of this argument is that policy makers in Bismarckian pension countries need not necessarily compromise with interest groups to fend off their vetoes They can also rely on the support from political parties to overcome their vetoes They count on either of these two types of support or sometimes mix them to implement pension reforms This analysis clearly depicts the changing nature of recent reforms of Bismarckian pension system The similarities and the differences found in case studies in terms of the mix of the two types of consensus building have implications on the literature on varieties of capitalism in these countries It also sheds a new light on the importance party politics plays in institutional reform in a political system with multiple vetoes **A History of the German Public Pension System** Alfred C.
