I shall review the problems of unwanted effects and dependence mainly from an epidemiological view point and then relate the pharmacological properties of the newer compounds to possible differences in their clinical profile of adverse effects. Adverse behavioural effects: Benzodiazepines are used *inter alia* as anxiolytics and hypnotics. The latter use exploits the sedative actions which occur at higher than anxiolytic doses. The sedation should disappear by the time the patient wakes up. Hypnotics are thus unique in that their wanted effect and unwanted effect are identical: sedation, but separated in time by about 8 hours.
