  - o Plaintiff files a complaint. The complaint names the parties to the lawsuit, alleges the ultimate facts and law violated, and contains a "prayer for relief"
  - o Court issues a summons
  - o The party being sued, the defendant, must file an answer to the plaintiff's complaint.
    - Must admit or deny allegations
    - Failure to answer results in default judgment
      - Plaintiff only has to prove damages
    - Can assert affirmative defenses (self-defense)

  - o Legal process provides for a detailed pretrial procedure
