- The reform of electricity markets encompasses a wide range of measures.
- In general electricity industry restructuring implied:
 - √ a separate transmission company;
 - ✓ partially or totally privately owned generation companies;
 - ✓ competition in generation;
 - ✓ retail supply opened to competition;
 - privately owned transmission and distribution network with third party access based on published and non-discriminatory terms and conditions.
- Electricity industry restructuring has been accompanied also by the reform of the institutional design resulting in a set of institutional bodies:
 - ✓ ministry handling most regulatory responsibilities directly;
 - ✓ independent regulatory agencies separate from ministry taking care of some particular responsibilities operating on the base of public consultation and other procedures meant to enhance transparency;
 - ✓ presence of ministerial regulatory agencies subordinated to the ministry but operating autonomously in the management of regulatory affairs.
