

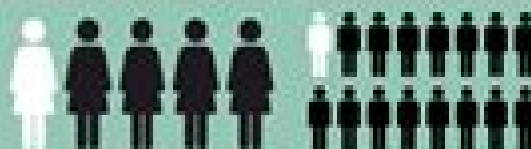
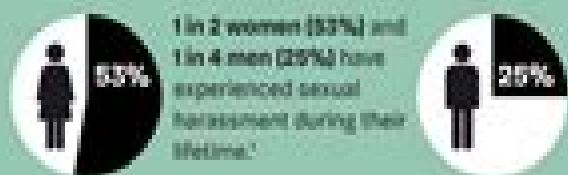

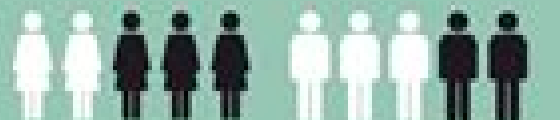

## Australians experience sexual violence at an alarming rate.



1 in 5 women (20%) and 1 in 10 men (10.1%) have experienced sexual violence since the age of 15.<sup>2</sup>

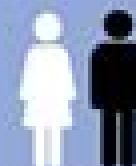
Young women aged between 15 and 17 years old are the most common victims of sexual assault. Young men aged between 15 and 19 years old are the most common offenders of sexual assault.<sup>3</sup>



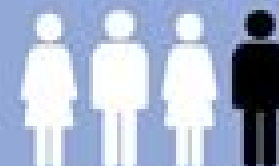
2 in 5 young women and 3 in 5 young men reported using pornography as a source of information to learn about sex and sexual relationships in the last 12 months.<sup>4</sup>



## We want to create a shared understanding about consent.<sup>7</sup>



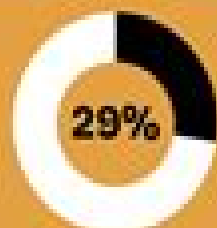
1 in 2 Australians (48%) are conflicted in their understanding of consent.
