In Number One Court, worse of so many lesser ones, they listened to the trial of the man accused of attempting to murder two police officers by running them down in a van which, it was alleged by the prosecution, had been stolen.

Everybody in Court stood when the Princess entered, to take their seats behind the baronet's benches. They, in their turn, rose with everybody else when the Lord Chief Justice of England, Lord Goddard, tilted in velvet and ermine, came on to the bench. In this place His Majesty's judge took precedence over the King's daughter.

For the first time in their lives, the Princess heard a jury sworn in, the jurors swearing on oath that they would "well and truly try, and true deliverance make, between our Sovereign Lord, the King, and the prisoner at the Bar. . . . And a true verdict give, according to the evidence."

They remained until the mid-day adjournment, listening to prosecuting counsel's outline of the case and to the evidence and cross-examination of witnesses called for the Crown. Watching the slow, relentless working of the law, they seemed deeply impressed.

THURSDAY, MARCH 23, 1940. The King today underwent an operation, known as lumbar sympathectomy, to free the flow of blood to his right foot. Not a dangerous operation, the doctors had said; but there is always some anxiety attaching to any operation. It was a happy duty, therefore, to send out the first bulletin indicating that all was well. "His Majesty's condition," it said, "is entirely satisfactory." The news, flashed round the world in a matter of minutes, was received with relief by millions of people. This morning there was a second of equally reassuring bulletin. The King had a restful day following the operation, and the doctors' temperature, pulse and respiration had not varied from normal.

Everybody has advised the King that he should rest with his desk work all the time, and official visitors in audience and hospital visits have been postponed. But we shall see him steadily on the march.

FRIDAY, MARCH 23, 1940. Good news came in this morning. Good news which the doctors are obviously very cautious with, but which progress that the King is making, they did not return this evening.

A cold, grey day but many people leaving the Palace, at the railings, for news of the King. What is it that brings them there? Talk to them and you will find that it is not mere curiosity. Respect, affection, sympathy leads them and they wait in the cold and the rain, a quiet and patient crowd of well-wishers.

They cheered the Queen when, in the late afternoon, she drove down the Mall to the Marlborough House to have tea with Queen Mary.

FRIDAY, MARCH 23, 1940. To get to Canning Town, you drive through the East End of London; along the innumerable length of the Commercial Road, then by way of that romantic-sounding thoroughfare, the East India Dock Road. So, at last, you will come to Canning Town. Twist and turn among the bomb-blinded streets and, where postmen deliver letters marked "London E. 16," you will find the Dockland Settlement which the Duke of Edinburgh visited to-night. That it is not easy to find is clear from the fact that the car from Buckingham Palace lost its way in the side streets.
