

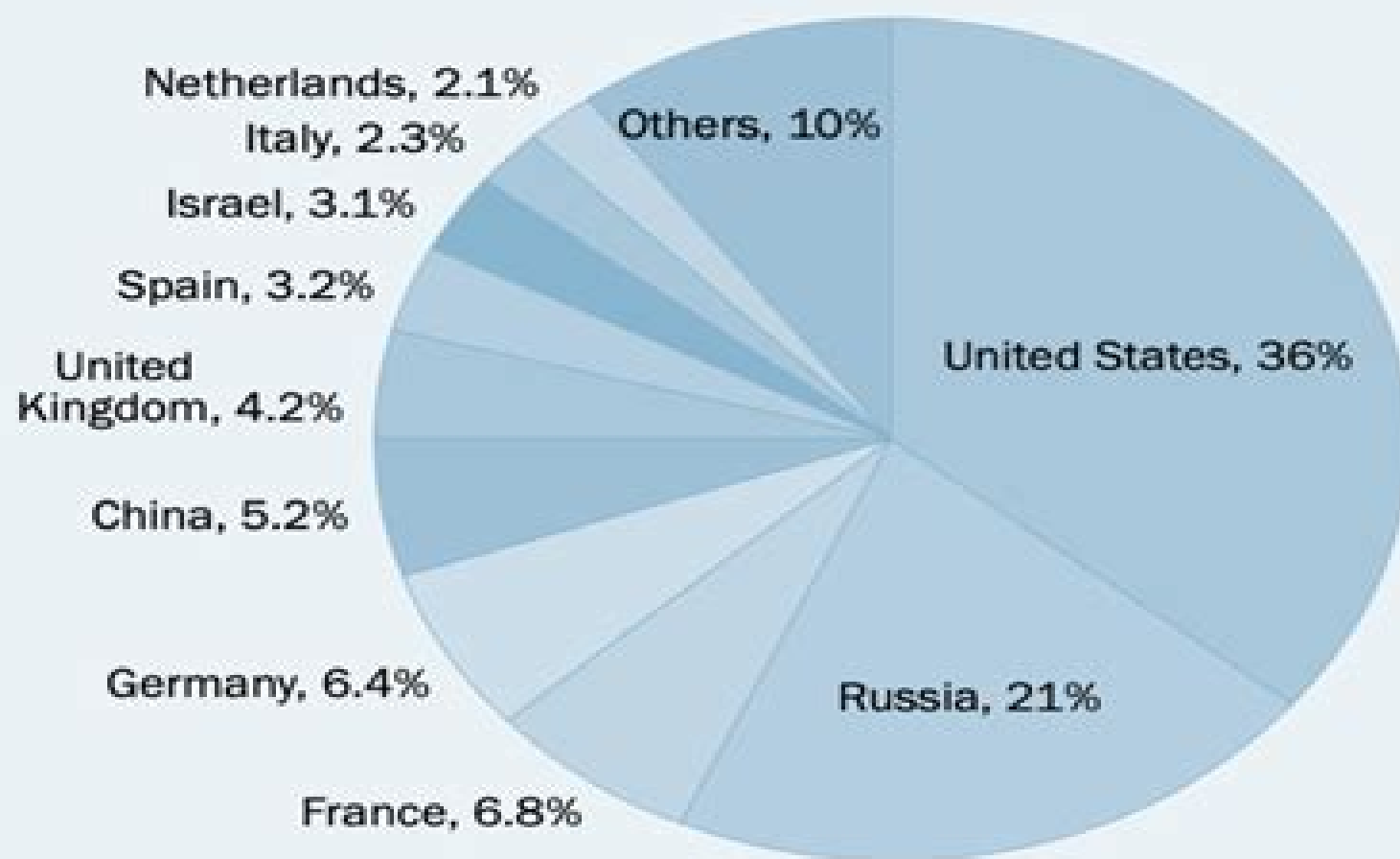


Figure 2. Global share of major arms exports by the 10 largest exporters, 2014–18
