This analytical inventory of entries in gaol registers for the Abbey of Saint-Germain-des-Prés in Paris in the sixteenth century is of particular interest to a variety of readers: French historians and also anyone interested in graphic accounts of indictments and arrests as exemplified, for instance, in the assize records for London. The 1637 cases reported cover 42 years and are completed by a triple index of persons, places and topics, typographically differentiated. An added bonus is the reproduction of eight palaeographical documents, with their transcriptions which not only offer a real help to the palaeographer of this period but also an essential insight into the actual setting of these documents which can be very confusing.

The inventory is presented numerically and under the date of entry, followed by identity of the prisoner, place of birth, age, calling and address. This is followed by specification of charge and date of discharge. Other relevant matters may be added under the rubric pièces jointes (enclosures). These entries present a multiplicity of interests, and particularly for the organization of civil and criminal proceedings and the personnel employed by the Abbey for its judiciary administration. It also gives an insight into the topography and population of the borough of Saint-Germain-des-Prés from the angle of criminality: rogues, vagabonds (both human and animal!); denunciations, violence and murders; the relationships between aristocrats and their servants; the specific offences committed by rurals and various craftsmen, etc. Thus, far from being a dry list of crimes committed in what was then a Paris suburb, we enter into the teeming life of a district peopled by the old nobility and the nouveaux riches, the motley crowd of priests and peasants, barbers and goldsmiths, prostitutes and tax-collectors, in their tussles with each other and with justice. Another great advantage of this inventory: the vocabulary is extremely simple and when, occasionally, an unusual word crops up, the author gives a modern equivalent. Last but not least, the appearance of the book (the responsibility of Erik Le Maresquier, Head of Publications of the Archives nationales) is both reader-friendly and unusually attractive. This valuable work makes compulsive reading and, at its moderate price, should easily find a place in the library of the scholar and the more general reader alike.
